## **Summary of Questions:**

- The questionnaire captured an overall very positive view of the school, raising no significant majority issues;
- All parents feel well informed about their child's achievements and progress;
- An overwhelming majority of parents felt that the format of parents' consultations have been effective – this would link to the parents feeling well informed;
- The majority of parents agree or strongly agree that communication is effective and that relationships are a strength of the school;
- Pupils at Kingsmoor are happy and enjoy coming to school;
- The results show how effectively parents feel that the school is well led and managed;
- Parents have acknowledged that the curriculum is broad and enriched.



#### Next Steps and Areas for Development:

- The role and presence of the governing body needs to be communicated to parents, with an increased visibility of governors within the school community and at key events;
- Explore opportunities to further develop opportunities for parents to make suggestions of how to improve – there was a group of parents who felt that they were not able to make suggestions; however, this was not the view of the majority.
